Dear President, Dear Guests, Dear Speakers, Ladies and Gentlemen,

Allow me, on behalf of the IRU President, Mr Janusz Lacny, our 180 Members in 72 countries around the world and myself, to congratulate the organisers, namely Mr Peter Zander, President of the Europäische Taximesse, and Mr Thomas Grätz, Vice-president of the IRU Taxi Group, for this extremely successful event, which has assembled taxi businesses and regulators from four continents.

I am particularly impressed both by the quality of the exchange of experience and by the professional approach of all the interventions during the debate. To do so, to be able to provide an effective lobbying with competent authorities, we must unite our forces, we need to work together within the IRU Taxi Group.

Unity creates strength. This is why, with the IRU President, Mr Lacny, with the President of the Taxi Group, Mr Andela, and all the members of the Taxi Group, we would sincerely welcome all those taxi associations who decide to join the IRU Taxi Group, to share this common objective.
