

## 1st IRU/EU Presidency Road Transport Conference & Ministerial Meeting *"Efficient, Safe and Sustainable Road Transport for the Future"* Brussels, Belgium, 1 December 2010 Closing Session

Excellencies, Ladies and Gentlemen,

Finally, according to the programme, I have the task of summarising the discussions of this conference and Ministerial meeting in order to allow each of you to take home the important results obtained.

One of the most significant conclusions of our work here in Brussels, as confirmed by all the distinguished speakers, is that road transport will continue to be one of the main modes of transport to meet the mobility needs of EU businesses and citizens.

Today's we have brought forward a range of ideas and concrete examples of how we can better ensure that road transport will be more efficient, safe and sustainable in the future. Let me just mention a few of the main conclusions:

As just mentioned by Secretary of State, Mr Schouppe, the IRU and its Members are not only pleased to note but committed to the reinforcement of cooperation between the private and the public sectors which is crucial to better achieve together the objectives set.

Secondly, the IRU is also pleased to note the general recognition that commercial road transport will remain the backbone of a strong, dynamic economy and society, and will indeed also remain a vital production tool and the key to ensure sustainable development.

Thirdly, due to the efficient, safe and sustainable road transport that we will be able to achieve by working together in the future, no other mode or sector will be able to take over or match the current and future contribution of commercial road transport in driving prosperity and progress in Europe.

Speakers and indeed the conference delegates confirmed that in order to deliver the economic and environmentally sustainable mobility needs of all EU citizens and businesses, EU governments should, as they have done today, continue to acknowledge the vital contribution of commercial road transport and reinforce their cooperation with the road transport industry.

Such cooperation in a public-private partnership with the road transport industry should favour transport policies which enable:

- Market driven free modal choice,
- A well directed and funded infrastructure policy,

- More secure commercial road transport through the provision of information from Governments about the location of secure parking areas and the creation, where needed, of additional truck parking areas,
- A single EU-wide enforcement space to fight crime and to avoid unjust fines,
- Increased focus on innovation and vocational training, notably through reinforced cooperation with the IRU Academy,
- A commitment to promote the Smart Move campaign which aims to double the use of bus and coach transport.

These proposals are all reflected in the text of the Conference Declaration that has been widely circulated.

Please allow me to call on you to adopt the declaration.
