### 2.1.1 EU Licence, ECMT Authorisation, Bilateral or Transit Transport Authorisation

### 2.2 Driver's Documents (foreign vehicle)

### 2.2.1 Proof of ID

person(s) sanctioned: driver

sanctions: typical fine of DKK 500 which the police may claim on the

spot. Jail up to 6 months is a possibility in grave cases

(Law nr. 808 of 8. july 2008).

compromise settlement: no information

other measures: Vehicle and driver detention until the fine is paid

### 2.2.2 Driving permit

person(s) sanctioned: driver

FGBKG: Ministerial Order nr. 705 of 21. june 2007on transport of Dangerous Goods

In Denmark, there is no maximum limit for fines. The minimum is DKK 500, and any other amount above this one should be in multiples of 500. There are catalogues for setting the amount of the fine for each specific case.

#### 2.4 Transport documents on board foreign vehicles

### 2.4.1 Consignment note / CMR international consignment note

• person(s) sanctioned: carrier, driver

sanctions: Typical fine of 500 – 1.000 kr. (Law nr. 867 of 13.

September 2005) in case of failure to produce the CMR consignment note (forgotten, lost) or of compulsory items checked by the Administration not filled in

compromise settlement: no information

other measures: Vehicle, cargo and driver detention until fine is paid

#### 2.4.2 Loading list (groupage)

person(s) sanctioned: carrier, driver

sanctions: Typical fine of 500 – 1.000 kr. (Law nr. 867 of 13.
September 2005)) in case of inaccurate loading list or failure to produce it within three

days

• compromise settlement: no information

other measures: Vehicle, cargo and driver detention until fine is paid

## 2.4.3 ADR transport document, consignor's declaration, ADR security instructions

• person(s) sanctioned: carrier, driver

• sanctions: typical fine of DKK 500 which the police may claim on the

spot (FL, FGBKG) in case of failure to draw up or to produce document or for submission of incomplete or non

complying document

• compromise settlement: no information

other measures: Vehicle and driver detention until fine is paid

### 2.4.4 Container packing certificate

person(s) sanctioned: carrier, driver

sanctions: typical fine of DKK 500 which the police may claim on the

spot (FL, FGBKG) in case of failure to draw up or produce

the certificate

compromise settlement: no information

other measures: Vehicle and driver detention until fine is paid

#### 2.4.5 Transfrontier movement of waste document (Basel Convention)

person(s) sanctioned: carrier, driver

sanctions: typical fine of DKK 500 which the police may claim on the

spot (Ministerial Order Nr. 799 of 28. of June 2007)

compromise settlement: no information

other measures:
Vehicle and driver detention until the fine is paid

### 2.5 Excess load of foreign vehicle

person(s) sanctioned: carrier, driver

• sanctions: Fine calculated after DKK 250 times # percent of excess

load (carrier) and DKK 100 times the percentage for the

driver

compromise settlement: no information

other measures: Vehicle and driver detention until fine is paid

### 2.6 Third-party insurance

person(s) sanctioned: driver, carrier

sanctions: typical fine of DKK 500 which the driver must pay on the

spot (FL, FGBKG) (Ministerial Order no. 673 of 26. June

2008)

• compromise settlement: no information

other measures: vehicle and driver detention until fine is paid

### 2.7 Obligation to produce required documents

person(s) sanctioned: carrier, driver

• sanctions: Typical fine of 500 - 1.000 kr. (Law nr. 867 of 13.

September 2005) in case of refusal to produce

required documents

Fine from 500 DKK (But typically higher) Prison up to 8 years in grave cases. (Law nr.1168 of 6. November 2008, The Penal Code) in case altered documents are used or

in case of document forgery

• compromise settlement: no information

• other measures: Vehicle immobilisation, cargo immobilisation, custody of the

driver

#### 2.8 Obligation to submit to a decision to immobilise the vehicle

person(s) sanctioned: no information

sanctions: Typical fine of 1,500 – 5,000 DKK (FL and RPL)

compromise settlement: no information

• other measures: Vehicle and cargo immobilisation, possibly custody for the

driver
