




# **Results of private sector participation?**

- **Boost Tourism** : It will give big boost to tourism: Places of tourist interest will not only remain well connected but will also get served by better bus facilities at economical rate.
- **More Employment** : It will generate large employment opportunities: it will not only give employment to large number of people connected to only bus services but will also create more opportunities within tourism industry.
- Reduction in pollution : It will reduce traffic congestion, air and sound pollution: One bus can carry people equivalent to at least 20 cars and 40 two wheelers; which will reduce traffic on road.
- Saving in foreign exchange : It will save foreign exchange for the country: low usage of personalized vehicles will save huge fuel in turn saving lot of foreign exchange.
- **Support growth in GDP:** Overall commuting will become efficient and economical giving rise to overall productivity of the country




