- **Overarching language barriers**

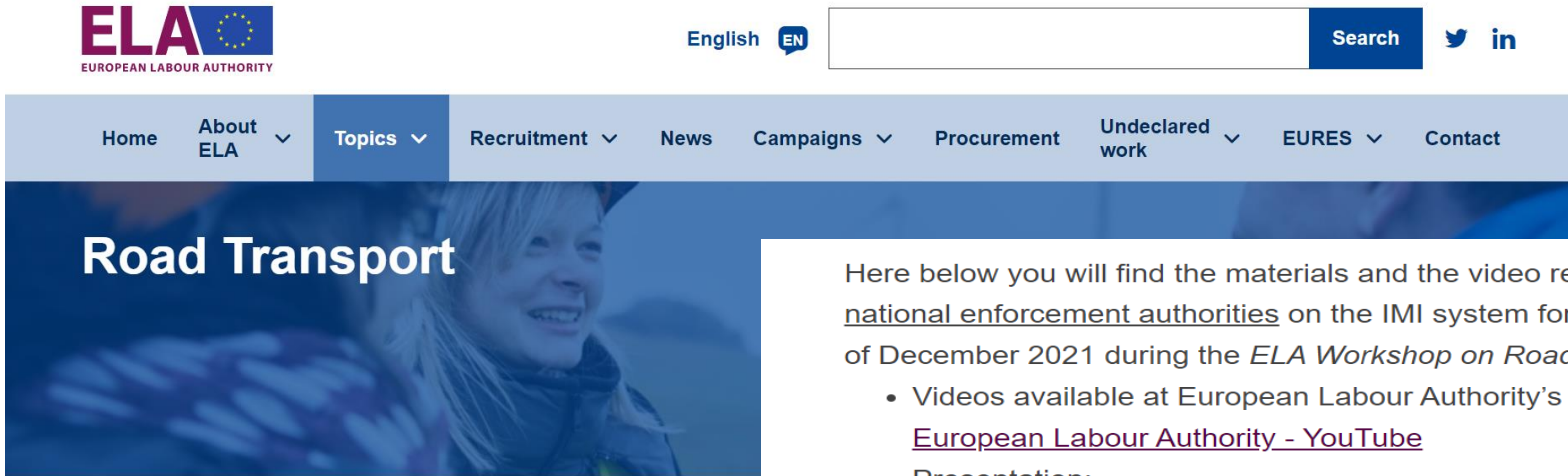
