

‘Check if you need to report for an inspection’ service (Inspection Location Service) - Phase 2 Exports GVMS release 3.1



Introduction



This presentation will focus on the Goods Vehicle Movement Service (GVMS) Release 3.1.

Enhancements are being made to the 'Check if you need to report for an inspection service' (you may hear this referred to as *Inspection Location Service (ILS)*) Phase 2 exports enhancement (movements from Great Britain to European Union).

It is relevant for hauliers and drivers to be aware of these enhancements and this presentation will give a view of the new export screen within the 'Check if you need to report for an inspection' service (ILS).



Inspection Location Service (ILS) Phase 2



Inspection Location Service Phase 2 is an enhancement to the messaging included within the 'Check if you need to report for an inspection' service which will now include Export Movements.

This update will also make some changes for Imports into 10 Border Locations notified within the ILS.

If you are moving goods between Great Britain and the European Union, you may need to attend an Inland Border Facility (IBF) or Border Control Post (BCP) for an inspection.

From Midnight on 30 May 2022 the enhancement to the messaging for Export Movements will tell you which inspection site(s) you need to attend and the nearest border location.



ILS Reference Data Update (ILP Removal)

Currently the ILS service shows the BCP's with their corresponding addresses for Import movements, however GVMS R3.1 will remove these BCP locations and will only display an 'Inspection Required' message at the following Border Locations:



- Aberdeen
- Harwich
- Hull
- Immingham
- Killingholme
- Port of Tyne
- Purfleet
- Teesport
- Tilbury
- Felixstowe

These changes will be deployed on 30th May 2022.



Check if you need to report for an inspection service - inclusion of export messaging

This is a new page in the 'Check if you need to report for an inspection' service, which tells you that your goods require an inspection and what to do next.

You can see it will show you the nearest inspection sites.

The goods you are moving require an inspection

What to do next

Report to your nearest inspection site.

Check which inspection site(s) you need to attend at your border location of departure. You may have to drive to an inland border facility (IBF) or customs checking facility.

Goods needed for inspection must be kept in the same condition as when they were imported.

! You may be charged a penalty if you do not arrive for an inspection

Your nearest inspection sites

The inspections must take place in the order shown.

If you cannot attend your nearest inspection site, you will need to go to another.
